Interactive Learning Session on CAADP Country Roundtable Processes 9th and 10th of February

Concept and Process

The purpose of this meeting will be to not only take stock of the emerging lessons, but to strengthen the depth of our understanding of these processes so that we emerge with a deeper consensus and a strengthened model of both the Roundtable Process and Pillar Framework concepts. This we feel will be critical to ensuring the success and quality of both the ongoing roundtable processes and those scheduled to launch in 2008.

The meeting will bring together the key actors in the Regional Economic Communities, the Pillar Institutions, and NEPAD Secretariat along with members of the CAADP teams in Uganda, Malawi, Rwanda and Zambia where the most progress has been made in moving the Roundtable Process.

The two day session will be a facilitated discussion and review with the expectation that partners will emerge with a renewed consensus and deeper understanding of the Roundtable Processes and Pillar Framework linkages. This will also serve as a useful benchmark for the Pillar 2 and 3 Donor Review which follows on the 11th through to the 14th.

Key Outcomes

Key outcomes from the session will include:

- (i) Common understanding/consensus on the CAADP Roundtable Process and Pillar Framework concepts;
- (ii) Clarity and consensus on how the CAADP Pillar Frameworks will support the Roundtable Processes;
- (iii) Strengthened Roundtable Process concept that has absorbed lessons learned from early country experiences.

The results of the session will be documented in to a short information and learning paper on the Roundtable Process which will be made available to all partners.

Timing

The Learning Session will commence at 8:30am each day and conclude at 6:00pm. Lunch and refreshments will be provided.
